Councilwoman Busteed-stated that for everyone in the audience, this resolution is to express opposition to the approval of HR38 and strongly oppose S446, the constitutional concealed carry reciprocity Act of 2017. She stated that this resolution is not about any changes to our second amendment rights but what it is about is this States right, and this community's right to have its own laws apply to everyone physically present in our state, whether you live here or visiting from another state. If this were to become law, it would require each state to recognize the concealed carry standard from every other state. In other words, as long as a visitor from our state is permitted to carry a concealed weapon in their home state, they would be allowed to carry a concealed weapon here too.

On motion by Councilwoman Busteed, seconded by Councilman Papaleo, resolution #18-129 was unanimously approved.

#18-129 Resolution to Express Opposition to the approval of HR38 and Strongly Oppose S446, the Constitutional Concealed Carry Reciprocity Act of 2017

WHEREAS, on December 6, 2017, the United States House of Representatives passed HR38, known as the Concealed Carry Reciprocity Act of 2017 by a vote of 231-198;

WHEREAS, on December 14, 2018, the United States Senate Committee on the Judiciary held hearings on a companion bill, S446, known as the Constitutional Concealed Carry Reciprocity Act of 2017

WHEREAS, both HR38 and S446 would require that every state recognize any concealed carry permits issued by any other state, regardless of standards, or lack thereof; and

WHEREAS, while most states issue concealed carry permits under some circumstances; standards, permit requirements can vary significantly among states regarding important factors such as who may be legally permitted to carry a firearm (concealed or otherwise); whether training is required; the type and level of training if required, and other requirements deemed appropriate by that state; and

WHEREAS, currently, many state prohibit out-of-state individual to carry firearms across and within their borders unless the permit issued by the individual's state-of-residence has the same standards and requirements as their own;

WHEREAS, some states do not even require a resident to have a license and/or to register a purchased firearm or a permit to conceal carry a firearm known as unrestricted or constitutional-carry states;

WHEREAS, the Concealed Carry Reciprocity Act of 2017 and the Constitutional Concealed Carry Reciprocity Act of 2017 both require all states to allow residents from unrestricted states to carry firearms across and within their borders;

WHEREAS, as approved, the House of Representatives approved bill, HR38, will also exempt concealed carry permit holders from the Gun-Free School Zones Act of 1990, which expressly forbids any unauthorized individual from possessing a firearm in a school zone; and

WHEREAS, the Borough of River Edge, like many other municipalities and states, requires applicants to demonstrate a specific need for obtaining a concealed-carry permit; and

WHEREAS, should the United Senates pass S446, the Constitutional Concealed Carry Reciprocity Act and enacted into law with approval of the President of the United States, existing state and local laws will be superseded and limit the Borough's ability to prevent people from other states from carrying loaded, concealed firearms within the municipal boundaries of the Borough of River Edge.

NOW, THEREFORE, BE IT RESOLVED for the reasons cited above the Mayor and Council of the Borough of River Edge express opposition to the approval of HR38 and strongly oppose S446, the Constitutional Concealed Carry Reciprocity Act of 2017;

BE IT FURTHER RESOLVED that certified copies of this resolution shall be sent to Representative Josh Gottheimer, (NJ Congressional District 5), and New Jersey Senators Robert Menendez and Cory Booker, and;

BE IT FURTHER RESOLVED that certified copies of this resolution shall also be sent to the Borough's State representatives, Assemblymen Timothy Eustace and Joseph Lagana, Senator Robert Gordon and Governor Phil Murphy.

WHEREAS, Vito Acquafredda was born on October 9, 1954 in Bitonto, in the Puglia region of Italy and immigrated with his family to the United States in November 1970, and;

WHEREAS, Vito earned a Bachelor of Architecture and Bachelor of Science degrees from the City of College of New York and had a successful career as a Registered Architect in the States of New York and New Jersey, and;

WHEREAS, Vito married his wife Maria-Francesca (Francesca) on August 21, 1982 and in 1987, moved from Fort Lee, NJ to River Edge where they raised their son, Anthony and daughter, Emanuela (Emi), and;

WHEREAS, Vito, although forever proud of his Italian heritage and culture, became a naturalized

citizen of the United States, and;

WHEREAS, Vito served his community as a coach for River Edge Little League, the River Dell Soccer Association and the Black Hawks Soccer Travel Team, where he coached the Boy's team from 1991-2003, and;

WHEREAS, Vito further served his community as a member of the River Edge Traffic & Safety Committee; a member of the River Edge Board of Adjustment from 1994-2010; several years as either the Chair or Vice Chair; and a member of the River Edge Planning Board, and;

WHEREAS, Vito further served his community by being elected to the River Dell Regional Board of Education in 2002 and re-elected in 2005, 2008 and 2011 serving three years as Vice President and three years as President of the Board, and;

WHEREAS, Vito further served his community being elected to the River Edge Borough Council in 2012 and re-elected in 2015 and was looking forward to running for re-election again this year, and;

WHEREAS, Vito was selected by his Council colleagues to serve as Council President in 2012 and was chosen to serve again in this capacity for the year 2018, and;

WHEREAS, as a valued member of the Borough Council, Vito was held in the highest-esteem, respected and admired by many across the political spectrum, and;

WHEREAS, Vito entered into eternal rest on Monday, March 5, 2018 and his passing is a cause for deep sadness in our community and leave a presence on the Council dais that will be greatly missed.

NOW, THEREFORE BE IT RESOLVED, that I, Edward J. Mignone, Mayor of the Borough of River Edge, and on behalf of the Borough Council, publicly express profound sorrow at the loss of our colleague and friend, Council President Vito Acquafredda; and find comfort that his knowledge, intellect, wisdom, passion, dedication and desire to always do what was in the best interests of his fellow residents ensure an enduring and constructive legacy to his beloved adopted hometown of River Edge.

COUNCIL COMMENTS -

Councilman Papaleo-stated that Vito Acquafredda was a man on a journey, in the biblical sense as he was always moving from moment to moment in his life. He met Vito in the early 90's and reconnected with him here on the Council. He was always looking to do service and always looking to serve his community. He feels that the phrase "he was bigger than life" was a great phrase for Vito because anyone who met and connected with Vito their lives were changed. He was a man who challenged you and a man who challenged himself. Councilman Papaleo said that he was someone that he will miss and he wishes him well in paradise.

Councilman Bartelloni-said his wife first met Vito back in 2001 when he was the President of the Board of Education and hired her. When Alphone first ran for Council, he stopped her one night and asked if her husband was running for Council because he wanted to get to know him. Councilman Bartelloni got to know Vito briefly when he was the liaison to the Board of Education and got to see how he operated. He always noticed that when we take roll call, most of us say "here" and Vito always replied "present" and he has always thought about that. There is a difference in being here and being present. Although you can be here, sitting here but not necessarily present and that's probably why he said it. If you knew Vito, he had gravitas. Councilman Bartelloni always thought of him as older than he was, not in a bad sense but because he was someone that you knew you should listen to what he had to say. He and Vito always sat on

opposite sides of the dais and what he'll mist very much is that sometimes they would just look at each other and make eye contact and know that they were thinking the same thing. He will also miss not only what he would say but his dedication to the Borough especially when he came in during budget season when it was obvious he wasn't feeling well. He feels it's a tremendous loss for the town and for everyone on the dais and he will miss him very much.

Councilman Busteed-said that Vito was her friend and feels very lucky to have that friendship with him which she will value always. He treated her with kindness and he went out of his way to teach her and support her while on the dais as well as personally. When Vita was ill, her husband was ill and he would come to the house to see how they were which meant the world to them. She will never forget the kindness that he showed them. She will also never forget how he fought to the absolute last moment to be engaged in his work, with his family and here and she doesn't know if she would have the strength to do that. She will miss him tremendously and is sure that during future dialogues that they will have "Vitoisms" in them and feels that they will be better for it. They will hopefully find some joy in knowing that his presence is still here and she thanked Vito for being the friend that he was to the Borough and to her and extended her condolences to his wife Francesca, his children, Anthony and Emi and his extended family for their loss.

Councilwoman Davis-said that she only knew Vito casually before she became a council member but after sitting next to him, she can't explain how much he has taught her. He was so knowledgeable and had a great sense of humor and she really got to know him on a social level as well. His fight against a horrible disease was unbelievable and her fondest memories on this council is sitting next to Vito and learning from him and knowing what a wonderful man he was. She extended her deepest sympathy to Francesca and her family and all she can say that we will all miss you Vito and we count on you to watch over us.

Councilman Chinigo-said that Vito was a man that he greatly admired. He felt that they had a lot in common such as being born in another country and coming to the United States and they both were educated in much the same way. He always enjoyed his conversations with Vito. He broke bread with Vito and talked in length with him about issues facing our community. Although he knew him the shortest amount of time of most in this room, he will miss his wise counsel, his unabashed pragmatism and his wry sense of humor. He extended his condolences to his family and to all of us here who lost a great man and he will be sorely missed.

<u>Alan Negreann</u>-stated, notwithstanding everything that's already been said, he doesn't think he's ever met anyone who has had a great appreciation for their family, for their God, their community and for their country. For that he'll always be grateful because he opened his eyes up again that we should appreciate everything we've been given and he certainly did.

<u>Tom Sarlo, Esq.</u>-stated, as a Councilman he loved a good debate and at times tried to foster the debate but never wavered on his opinion. He disagreed when necessary but also compromised and there were some great attributes that he respected and learned to adopt as a council person. He also got to know Vito outside of here and listening to his stories was fantastic. As his dad always said, he was one of the good guys. Rest in peace Vito.

Mayor Mignone-said that if you could ever call someone on the local level a statesman, he was a statesman even if it was just in our town. There were three separate occasions over the past few months where he received text messages from Vito that he wanted to resign from the Council because he felt he wasn't doing his job. The Mayor told him that as long as he can talk with him and has access to his brain, they are all happy to keep him up here as long as he wanted to be here. His wife told the Mayor that he was especially proud that he was able to stay on and she was very appreciative of all the emergency services and Borough personnel. She also told the Mayor that when she walks past River Dell she sees Vito in the design of the addition. He certainly will have a lasting impact and will be a very different council but we will learn his lessons and try to keep his priorities and run the government the way he thought we should.

NOMINATION TO FILL COUNCIL SET CREATED BY THE PASSING OF COUNCIL PRESIDENT VITO ACQUAFREDDA ON MARCH 5, 2018

On motion by Councilwoman Busteed, seconded by Councilman Papaleo the nomination of Joseph Gautier to fill the vacant council seat was unanimously approved.

OATH OF OFFICE - NEW COUNCIL MEMBER -

Mayor Mignone administered the Oath of Office to Joseph Gautier.

OPEN HEARING OF THE PUBLIC -

On motion by Councilman Papaleo, seconded by Councilman Chinigo to open the hearing to the public was unanimously approved.

<u>Casey Connors-259 Adams Avenue</u>- asked Mr. Sarlo if he has gotten in touch with the attorney from Trenton?

<u>Tom Sarlo, Esq.</u>-replied, no I have not received any further communication. He said that there's nothing further for them to do with this at this time. The Borough has the list of the sidewalks that need to be repaired and the last they heard, John Lynch was prioritizing them and it would be up to the borough to determine when and how they will be fixed. He said that he would be happy to reach out to attorney and give her an update.

<u>Casey Connors</u>- asked if there's someone in town, an employee that is qualified to do self-assessment? <u>Tom Sarlo, Esq.</u> –said that the last time we left off, John Lynch was going to inspect the property locations for the list that we had.

Mayor Mignone-asked Alan if this would be part of the transition plan?

Alan Negreann-stated that if that's what he's referring to, it would be part of the transition plan.

Casey Connors-asked if there is a full-time employee that does that?

Mayor Mignone-explained that most towns have a committee.....

<u>Alan Negreann</u>-explained that he would be the full-time employee responsible for the transition plan. We have a plan but it needs to be updated.

<u>Casey Connors</u> – said that someone needs to do that because he posed that question back in 2007 and it's required by law.

<u>Mayor Mignone</u>-explained that we have made improvements in public facilities over the last several years for public accommodation.

Casey Connors - said that the ramp at Roosevelt does not have enough room for a landing.

<u>Mayor Mignone</u> - asked Councilman Chinigo as liaison to the school board to bring it up at the next Board of Ed meeting.

Mayor Mignone-said that it's a challenging process for all the towns. The Mayor informed Mr.

Connor's that the County will be changing the timing of the light at Continental Avenue. He's asked the County to evaluate all of the intersections and the countdown timers to allow more time to cross.

<u>Casey Connors</u>-suggested that since the town is being torn up by PSE&G, why not speak with them now to have electric and telephone lines put underground.

<u>Mayor Mignone</u>-explained that the issue that they run into when they do it after the fact, is that it requires putting a transformers on the street and tie the houses in that way and you'll still have some overhead wires. The possible cost per block could be a million dollars.

Casey Connors-for the town?

Mayor Mignone-replied yes, they wouldn't pay for it.

<u>Casey Connors</u>-asked why 3 or 4 officers were hired since there was only one officer who retired? <u>Mayor Mignone</u>-explained that we've had promotions and two officers transferred to other departments in a relatively short period of time so we don't have any more officers than we originally started with. <u>Casey Connors</u>-commended the DPW for the way they cleared the streets during the last storm but asked that they be reminded that they are required to clear off the curb cuts.

<u>Joe Manzelli-789 6th Avenue</u>- thanked the Mayor and Council for the memorial proclamation for Mr. Acquafredda. He said that he was a great man, friend and fellow board member at River Dell who will be sorely missed. He congratulated Mr. Gautier on his appointment this evening. <u>Mayor Mignone</u>-thanked Mr. Fletcher and Dr. Ben Dov for lowering the flags.

CLOSE HEARING OF THE PUBLIC -

On motion by Councilman Bartelloni, seconded by Councilwoman Davis to close hearing of the public was unanimously approved.

COUNCIL COMMENTS –

<u>Councilman Gautier</u> – thanked Tom, Ellen, Dario and Marie for nominating him and looks forward to working with everyone on the Council. Although he didn't know Vito as well as everyone here, he knows they his shoes will be hard to fill. He feels that it is a great honor to serve on the Council and looks forward to serving the people of River Edge.

Councilman Bartelloni- said that he did meet with another vendor for the T.V and feels that we're getting there. The last few years he's done tours of Borough Hall for the 3rd grade and has put two dates aside which are May 17th and June 14th and asked if anyone would be available to come they're more than welcome to do so. He said that there are 4 3rd grade classes and they usually give them a tour of Borough Hall, the Police Station and the Firehouse. This year they'll study civics towards the end of the year so he'll give them a lesson on that. He welcomed Joe Gautier to Council.

Councilman Papaleo-welcomed Joe to the Council and is sure that he will put an honest effort forth and work hard for the town. He again commended the DPW for serving with distinction during the last snow storm and informed everyone that they literally worked more than 24 hours during the storm. They are always proactive with brining the roads before they start to plow. John makes sure that they have their breaks and have something to eat during that time and Councilman Papaleo feels that they Mayor and Council have complete trust in them. He reported that the Beautification Committee had to cancel their meeting because of the storm but Shade Tree did meet on March 15th and had a very productive meeting.

<u>Councilwoman Busteed</u> –congratulated Joe on his appointment and said she looks forward to working with him. She reported that the Environmental Commission had asked her to bring two items to the Council's attention. One, they are going participate in the bi-state clean-up which is a group of towns that get together on the same day to clean-up parts of their borough on April 28th. Part of the challenge is weighing the waste that has been collected and she handed out information on this program. Their intent is to have the Kinderkamack corridor as their clean-up site and she asked if there are any approvals or waivers that are needed before they do that.

Mayor Mignone-said that he doesn't think so.

Councilman Papaleo-suggested that they contact the Police Department.

Councilwoman Busteed-said that she will let them know they can proceed with making their announcements. Laura Hoogstrate has been working with Lisa Hessman to see what their needs are. The other thing that they are working on are recycling programs. They've had 4 students come in from River Dell to talk about their recycling efforts when they were Cherry Hill students. They are working on items that are not normally recyclable such as Capri Sun juice pouches, pencils, markers and pens. They're also looking to start a Trex Challenge for Recycling which is a plastic film recycling. There is a company that will take grocery bags, bread bags and dry cleaning bags that can be collected at designated sites. If you meet the challenge of 500 lbs of this plastic film, the company called Trex will create a bench out of the material and donate it to the Borough. The Environmental Commission is going to take this challenge on from April through October and the company will provide the bins and Environmental Commission will be responsible for dropping them off at Whole Foods which is a collection site. They're going to place bins in each of the elementary schools and would also like to place a bin in the Library and at the Farmer's Market. Councilwoman Busteed asked Councilman Chinigo if he would reach out to the Library Director and also asked Councilwoman Davis to reach out to the Farmer's Market Committee to see if they would be on board with this idea. She feels that they are really trying to take an active role to promote recycling in the Borough. Arlene Faustini had asked that she promote a Stigma Free program that will be held in the Library on Wednesday at 7 p.m. on Childhood Anxiety.

Councilwoman Davis-welcomed Joe to the Councilman Gautier. She reported that the Fire Department had a storm stand-by and fortunately they had no calls which was much better than the last storm when they were slammed. She also reported that the Health Department didn't have a meeting in January due to a lack of quorum but they will have one this evening and will be welcoming a new member, Jane Daly. Councilwoman Davis attended SCORE meeting today and was told that they have a few new members. She said many people keep asking when the Community Center will be complete because many people don't like the current setup. She hopes that the plans will be moving along with Vito watching over them.

Councilman Chinigo-also congratulated Joe on his appointment and feels he will be a great asset to the Council. He thanked Chief Cariddi and Officer Estevez for taking time out of their schedules last week to give Scout Pack 229 a tour of the police facility. At the last River Edge Board of Education meeting that he attended, the board asked him to bring up to the Council the idea and future possibility of moving the election sites from the school to somewhere else. The board would like to broach the subject based on safety concerns about individuals coming into the schools when there are children present. He feels Roosevelt is a special concern because of where the election is and the accessibility of people to the school. He suggested that it be listed for a work session so they can discuss.

<u>Mayor Mignone</u>-stated that this is something that they've been asking perennially and we just don't have an appropriate space to do it.

<u>Councilman Chinigo</u>-said that hopefully we're building something that may be able to accommodate it. <u>Mayor Mignone</u>-explained that it might take some of it down the line.

Councilman Chinigo-reported that the Library will be meeting next week. At the last meeting, the Library Board asked him to broach the subject about HVAC system and starting work, separate from the Community Center. They are currently exploring the possibility of grants to help with the expense. Mayor Mignone-reported that on the Community Center, the architect and the HVAC engineer are looking at utilities both for the Community Center and the Library. He's waiting on sharp pencil estimates on the construction costs because they're going to be working on a very tight budget and there's not a lot of room for error. He feels that before they roll the plan out publically, he wants to make sure that it's something that we can actually do. He hopes by the next meeting they'll have the information, it will be in our budget and we'll be able to start making some official presentations on the plan.
