MINUTES Regular Meeting of the Mayor and Council Monday, April 9, 2018 Immediately Following Work Session

CALL THE MEETING TO ORDER -

Mayor Mignone called the meeting to order at 7:49 p.m. in the Council Chambers of the Borough Hall.

SILENT PRAYER - FLAG SALUTE

Mayor Mignone called for a moment of silent prayer and asked Councilwoman Busteed to lead the salute to the flag.

SUNSHINE STATEMENT -

Mayor Mignone read the statement under the Sunshine Law and asked the Clerk to put it into the minutes. "Adequate Notice of this meeting has been made by sending notice on December 29, 2017 to THE RECORD NEWSPAPER, by positioning on the bulletin board in the lobby of the Borough Hall and filing a Notice of the same with the Municipal Clerk".

ROLL CALL – Councilman Bartelloni, Councilwoman Busteed, Councilman Chinigo, Councilwoman Davis, Councilman Gautier, Councilman Papaleo and Mayor Mignone were present.

ELECTION OF COUNCIL PRESIDENT -

On motion by Councilman Papaleo, seconded by Councilman Gautier to appoint Ellen Busteed as Council President for the year 2018 was unanimously approved.

APPROVAL OF MINUTES –

On motion by Councilman Chinigo, seconded by Councilwoman Davis, the minutes of the Mayor and Council regular meeting of March 26, 2018 were unanimously approved.

PROCLAMATIONS & AWARDS -

Mayor Mignone read the Proclamation Declaring April as Donate Life Month as follows:

PROCLAMATION

WHEREAS, those who dedicate their time, effort and skills to help others are among the most valued members of any community; and

WHEREAS, there is a great shortage of organ and tissue donors and thousands of people on the organ transplant waiting lists will not live to receive one; and

WHEREAS, each day 3 people die while on the waiting lists and in New Jersey, over 5,000 residents are waiting for organs or tissue; and

WHEREAS, the New Jersey Motor Vehicle Commission is cooperating with the New Jersey Sharing Network (NJSN) so that you need only to designate on your driver's license that you want to be a donor and that information will also go into the NJSN computers; and

WHEREAS, if you are not a driver, you may designate your wish to be a donor on your legal I.D. card; and

WHEREAS, the NJSN has a new information brochure which contains a temporary

Donor Card to be filled out and kept in your wallet until you have the opportunity to register this information on your driver's license or I.D card.

WHEREAS, the science of matching and performing organ transplant surgery has become more advanced; and

WHEREAS, last year over 613 transplants were performed in New Jersey and over 189,000 were performed nationally; and

WHEREAS, it is possible for one donor to save up to 8 lives and enhance the lives of up to 50 others through tissue donation.

Councilman Papaleo-accepted the proclamation on behalf of the Shade Tree Commission.

Councilman Papaleo explained that they are planning an event for Arbor Day with the nursery schools and the girl scouts are coordinating with them to deliver saplings throughout the town. <u>Mayor Mignone</u>-explained that the Borough's Green Team is a group that was created through a program called Sustainable Jersey for environmental initiatives such as recycling, river clean up, etc. Through Sustainable Jersey, they have a recognition award called "Hero of the Month". The Mayor explained the criteria for this award and said that Bonnie did most of that work for recertification. Last year the Mayor sent in a recommendation for Bonnie to be considered a "Hero of the Month" and she was chosen as a "Sustainability Hero" for November 2017. The Mayor said that there was a three page article on Bonnie which listed everything that she has done. The Mayor presented Bonnie with a recognition award.

<u>Bonnie Stewart</u>-thanked the Mayor and Council for always helping her out with getting her the documentation that she needs and also thanked the residents who always come out for every event whether it's rain or shine. She informed everyone that they will be having another Second Hand Toy collection on April 21st at Cherry Hill School from 9 to 1 which helps keep plastic toys out of

our landfills. She again thanked the Mayor and Council for this honor.

OPEN PUBLIC COMMENTS ON ANY ITEM ON THE AGENDA -

On motion by Councilman Chinigo, seconded by Councilwoman Davis to open public comments on any item on the agenda was unanimously approved.

CLOSE PUBLIC COMMENTS ON ANY ITEM ON THE AGENDA -

There being no comments by the public, the motion by Councilwoman Busteed, seconded by Councilman Bartelloni to close public comments on any item on the agenda was unanimously approved.

OPEN HEARING ON 2018 BUDGET AMENDMENT

On motion by Councilwoman Busteed, seconded by Councilwoman Davis to open hearing on the 2018 budget amendment was unanimously approved.

<u>Alan Negreann</u>-explained that we are amending the introduced budget for a few grants; Clean Communities and the Alliance, a few snow emergencies, a reimbursement from the County for snow work on their roads and adjustments to a variety of other accounts with reductions and increases.

<u>Mayor Mignone</u>-stated "there is no change from the tax rate from last year still" correct? <u>Alan Negreann</u>-replied, correct. The tax levy is still the same as last year.

<u>Mayor Mignone</u>-commented that this is the third time in 25 years that he and the Council have been able to bring a budget forth that does not increase the local taxes. It's been a long difficult journey to get here and it's a path that we've been starting over the last 8 or 9 years. It's taken a lot of fiscal discipline, a lot of patience on behalf of the Council, the workers and staff to get our fiscal house back in order. We're in a better fiscal position than we were ten years ago and hopes that going forward we can maintain the discipline and try to keep the taxes increases to as low as we can. The Council has done a great job and they're very proud of this and he hopes that this will be a harborage for the future and not just a one time event.

CLOSE HEARING ON 2018 BUDGET AMENDMENT

There being no comments by the public, the motion by Councilman Chinigo, seconded by Councilman Bartelloni to close hearing on the 2018 budget amendment was unanimously approved.

On motion by Councilman Bartelloni, seconded by Councilman Chinigo, resolution #18-132 was unanimously approved.

<u>#18-132</u> Adopting 2018 Municipal Budget

WHEREAS, the 2018 Municipal Budget was approved by resolution #18-92 on February 6, 2018; and

WHEREAS, in accordance with N.J.S.A. 40A:4-6, was advertised in THE RIDGEWOOD NEWSPAPER on March 9, 2018; and

WHEREAS, the 2018 Municipal Budget was amended on March 26, 2018 via resolution #18-119; and

WHEREAS, the amending resolution was published in THE RIDGEWOOD NEWS on March 30, 2018; and

WHEREAS, a public hearing on the budget was held on March 26, 2018; and

WHEREAS, a public hearing was held on April 9, 2018 on the budget amendment;

and

NOW, THEREFORE, BE IT RESOLVED that the Local Municipal Budget appropriating \$15,901,549.63 be hereby adopted for the fiscal year 2018.

Ordinance #18-10 BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS, THE RECONDITIONING OF A FIRE RESCUE TRUCK AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW INFORMATION TECHNOLOGY EQUIPMENT, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT, NEW ADDITIONAL FURNISHINGS AND NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, IN, BY AND FOR THE BOROUGH OF RIVER EDGE, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$2,259,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS

<u>Mayor Mignone</u>-asked this is coming from this years capital budget? <u>Alan Negreann</u>-said yes, plus the addition of the Library HVAC and generator and ADA improvements.

On motion by Councilman Chinigo, seconded by Councilman Bartelloni, Ordinance #18-10 was unanimously approved for first reading as follows:

BOROUGH OF RIVER EDGE ORDINANCE #18-10

BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS, THE RECONDITIONING OF A FIRE RESCUE TRUCK AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW INFORMATION TECHNOLOGY EQUIPMENT, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT, NEW ADDITIONAL FURNISHINGS AND NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, IN, BY AND FOR THE BOROUGH OF RIVER EDGE, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$2,259,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS

BE IT ORDAINED by the Borough Council of the Borough of River Edge, in the County of Bergen, State of New Jersey, as follows:

Section 1. The Borough of River Edge, in the County of Bergen, State of New Jersey (the "Borough") is hereby authorized to make various public improvements, to recondition a fire rescue truck and to acquire new additional or replacement equipment and machinery, new information technology equipment, new communication and signal systems equipment, new additional furnishings and new automotive vehicles, including original apparatus and equipment, in, by and for said Borough, as more particularly described in Section 4 hereof. Said improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. There is hereby appropriated to the payment of the cost of making the improvements described in Sections I and 4 hereof (hereinafter referred to as "purposes"), the respective amounts of money hereinafter stated as the appropriation for said respective purposes. Said appropriation shall be met from the proceeds of the sale of the bonds authorized and the down payment appropriated by this ordinance. It is anticipated that the following government grants shall be received by the Borough: (A) a grant pursuant to the New Jersey Library Construction Bond Act to finance the cost of the improvements at the Public Library described in Section 4.E hereof; and (B) a grant from the Assistance to Firefighters Grant Program to finance the reconditioning of the fire rescue truck described in Section 4.K hereof. Said grant funds shall be applied as set forth in Section 12 hereof. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that the making of such improvements is not a current expense of said Borough.

Section 4. The several purposes hereby authorized for the financing of which said obligations are to be issued are set forth in the following "Schedule of Improvements, Purposes and Amounts" which schedule also shows (1) the amount of the appropriation and the estimated cost of each such purpose, and (2) the amount of each sum which is to be provided by the down payment hereinafter appropriated to finance such purposes, and (3) the estimated maximum amount of bonds and notes to be issued for each such purpose, and (4) the period of usefulness of each such purpose, according to its reasonable life, computed from the date of said bonds:

SCHEDULE OF IMPROVEMENTS, PURPOSES AND AMOUNTS

A. Supplemental funding for the undertaking of various improvements to the River Edge Senior/Community Center. It is hereby determined and stated that the Borough has heretofore appropriated the aggregate sum of \$1,047,100 for such improvement pursuant to the following five ordinances: Ord. No. 1789 adopted on May 6, 2013; Ord. No. 1806 adopted on April 21, 2014 (as amended by Ord. No. 1825 adopted on March 16, 2015); Ord. No. 1829 adopted on May 4, 2015; Ord. No. 1859 adopted on April 18, 2016; and Ord. No. 17-12 adopted on May 1, 2017.

The cost of such purposes, as hereinbefore stated, includes the aggregate amount of \$145,755 which is estimated to be necessary to finance the cost of such purposes, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 6. It is hereby determined and stated that moneys exceeding \$112,950, appropriated for down payments on capital improvements or for the capital improvement fund in

<u>Councilman Papaleo</u>-echoed what Councilman Bartelloni said and also extended his congratulations to Lieutenant Casey, Chief Schultz and our new Council President Ellen Busteed, He knows that Ellen will do a great job.

Council President Busteed- reported on a few Recreation Commission announcements. The River Edge Run will be held on April 14th and so far they've had the highest number of entrants to date. In six months, if they collect 500 lbs, the company will turn it into a bench and donate to our community. She asked that everyone look for the bin on the day of the run and to continue to collect plastics because the challenge will conclude on River Edge Day in October. Councilwoman Busteed was asked by the Commission members to extend a thank you to Alan Negreann, Stephanie Evans, Judy O'Connell and Geeta Birnbaum for all of their hard work during the transition until the new Rec Director is in place. Bonnie Stewart mentioned that there will be a Second Hand Toy Collection on April 21st from 9 to 1 and Councilwoman Busteed encouraged everyone to bring their large plastic toys to Cherry Hill School early because last year the truck filled up very early. The PTO's of the River Edge Schools, River Dell Schools and Oradell Schools are organizing and running a program on Monday, April 16th called "Be Smart for Gun Safety" with Moms Demand Action.
