Regular Meeting of the Mayor and Council Monday, September 24, 2018 6:00 P.M.

CALL THE MEETING TO ORDER -

Mayor Mignone called the meeting to order at 6:00 p.m. in the Council Chambers of the Borough Hall.

SILENT PRAYER – FLAG SALUTE

Mayor Mignone called for a moment of silent prayer and asked Councilman Gautier to lead the salute to the flag.

SUNSHINE STATEMENT -

Mayor Mignone read the statement under the Sunshine Law and asked the Clerk to put it into the minutes. "Adequate Notice of this meeting has been made by sending notice on December 29, 2017 to THE RECORD NEWSPAPER, by positioning on the bulletin board in the lobby of the Borough Hall and filing a Notice of the same with the Municipal Clerk".

ROLL CALL – Councilman Bartelloni, Councilwoman Busteed, Councilman Chinigo, Councilwoman Davis, Councilman Gautier, Councilman Papaleo and Mayor Mignone were present.

WHEREAS, in the United States, Breast Cancer is the third most common cause of cancer deaths after lung cancer and colon cancer; and

WHEREAS, during National Breast Cancer Awareness Month, we renew our commitment to fighting this disease, raising awareness and supporting those affected by breast cancer; and

WHEREAS, death rates from breast cancer have been declining and this change is believed to be the result of earlier detection and improved treatment; and

WHEREAS, mammography, an "x-ray" of the breast, is recognized as the single most effective method of detecting breast changes that may be cancer long before physical symptoms can be seen or felt; and

WHEREAS, October 19, 2018 is National Mammography Day, a day set aside to promote the importance of regular screenings in the early detection and prompt treatment of breast cancer; and

WHEREAS, we recognize the innovative, lifesaving work of medical professionals, through their efforts to prevent, detect and treat make a difference in the lives of our citizens; and

WHEREAS, it is important to continue the fight against breast cancer and to reduce the risk of this disease among our citizens.

Mayor Mignone read the Proclamation Declaring October $7 - 13^{th}$ as Fire Prevention Week

into the record as follows:

PROCLAMATION

WHEREAS, cooking, heating, and electrical fires represent three of the nation's leading causes of home fires, and are collectively responsible for nearly half of all home fires and almost one-third of the associated fire deaths; and

WHEREAS, the vast majority of home cooking, heating, and electrical fires can be prevented by taking simple safety precautions; and

WHEREAS, developing a home fire escape plan and practicing it at least twice a year are critical to escaping a fire safely; and

WHEREAS, proper installation, testing, and maintenance of smoke alarms are part of a thorough home fire escape plan; and

WHEREAS, by preventing the leading causes of home fires, and by developing and practicing a thorough home fire escape plan, people can greatly reduce their risk to fire; and

WHEREAS, the Fire Prevention Week 2018 theme, "Look. Listen. Learn. Be aware – fire can happy anywhere" encourages the public to develop a home fire escape plan and make sure they have working smoke alarms; and

WHEREAS, the fire service of the Borough of River Edge is dedicated to the safety of life and property from the devastating effects of fire; and

WHEREAS, the members of the fire service are joined by other concerned citizens of this Borough of River Edge, County of Bergen, State of New Jersey, as well as other emergency service providers and safety advocates, businesses, schools, service clubs, and organizations in their fire safety efforts; and

WHEREAS, I Edward J. Mignone, Mayor of the Borough of River Edge, do hereby proclaim the week of

October 7 – 13, 2018 as Fire Prevention Week

This week commemorates the Great Chicago Fire of 1871, which killed more than 250 persons, left 100,000 homeless, and destroyed more than 17,400 buildings.

Mayor Mignone stated that we constantly give great praise and credit to the Fire Department as they know that they do an excellent job and also acknowledge and thank them for going into the schools to educate children on fire prevention measures. He feels that prevention is key in protecting life and property.

OPEN PUBLIC COMMENTS ON ANY ITEM ON THIS AGENDA -

On motion by Councilman Bartelloni, seconded by Councilwoman Davis to open public comments to the public on any item on the agenda was unanimously approved.

<u>Patricia Young-95 Lakeview Street</u>-stated that she and her husband Dennis have lived in town for over 22 years and had attended a Council meeting about a year ago to voice their concerns about excessive parking on their street due to the over population of the apartments. She said that a year or so ago, one of the candidates came door to door asking what their concerns were and they told him about the parking on Lakeview Street. He mentioned that the Council was looking at possibly putting angled parking on Bogert Road.

Councilman Papaleo-said yes, that was him.

Patricia Young-asked what the status is?

<u>Mayor Mignone</u>-explained that there's two potential projects going on. The Borough did receive a grant for approximately \$118,000 to do one phase of angled parking along Bogert Road. Patricia Young-asked if that will actually happen?

<u>Mayor Mignone</u>-said that he can't tell her how many spaces at this point because it's just in the design phase. He also stated that it will take many, many years to get sufficient parking for it to be significant but we need to start somewhere. The fact that we got the grant the first time, should bode well for us continually during future phases as we go forward. It has also been brought to his attention that the apartments are adding a significant number of parking spaces within their own property borders by removing some of the green space. Although he doesn't know details of the plan, he's heard that it's imminent.

<u>Patricia Young</u>-said that they continue to believe that the solution to the problem would be for the Council to put a limit on the number of occupants that can be in a one bedroom apartment. It seems that in the last five years, the population has mushroomed and she can't imagine how many people are living in the one bedroom apartments.

Mayor Mignone-said he doesn't know what the constraints are.

<u>Tom Sarlo, Esq.</u>-explained that it's a zoning thing and defining what an immediate family is, is very hard to enforce.

<u>Patricia Young</u>-she feels that the new building on Kinderkamack will just push overflow parking further towards Lakeview Street. Another item she wanted to address is that there's a house that's been for sale for over two years and the real estate listing shows that the rooms are vacant. She said that there are different people coming and going and she's heard that it's possibly being used as an Airbnb or something similar to that. She's read that in other towns they have policies against Airbnb's and would like to know what the town's policy is on that.

<u>Mayor Mignone</u>-explained that we have not adopted an ordinance and doesn't know if they've had the same number of incidents that other towns have had but it's certainly something we can look at. He suggested that we ask Mr. DeRosa to check to see if this house is really occupied by the owners or find out what the status is. The Mayor said that if it was an Airbnb now, it would be legal now unless the Council's inclined to passing an ordinance.

<u>Patricia Young</u>-voiced her concerns about a herd of about nine deer that have taken up residence in the back yards of houses between Lakeview and Zabriskie and completely decimating the foliage. She asked if they've spoken with other towns or possibly the County about what they're going about their deer problem? She said that it's out of control.

<u>Mayor Mignone</u>-said that he's not aware of other towns having anything specific in place and assumes that it would fall under the County Health Department.

<u>Councilman Gautier</u>-said that he doesn't believe there's any ordinance about deer control. <u>Mayor Mignone</u>-said that it might be worthwhile for us to reach out to the County to see if there's any kind of coordinated efforts that they have.

<u>Councilwoman Davis</u>-said that it's not only in that area, she said she's seen them on Kensington Road.

<u>The Mayor and Council</u>-all said that they've seen more free roaming animals that ever before. <u>Mayor Mignone</u>-told Mrs. Young that they will have Property Maintenance look into what's going on with the house that's for sale on the corner of Lakeview and Reservoir. He asked if there's still a problem with people parking to close to the corner on Lakeview?

Patricia Young-said that it's not as bad as it used to be.

<u>Mayor Mignone</u>-said that he had asked the Police and DPW to yellow curb it but probably some of the neighbors didn't want that to happen.

CLOSE PUBLIC COMMENTS ON ANY ITEM ON THIS AGENDA -

On motion by Councilman Bartelloni, seconded by Councilman Chinigo to close public comments on any item on the agenda was unanimously approved.

<u>Mayor Mignone</u>- explained that the hearing on local assessments for Oxford/Rutgers Phase III is the continuation of a project that we've been doing through the CDBG and it has been the Borough's procedure for a number of years, the properties and homeowners who directly abut and benefit from the improvements are assessed a portion of the engineering fees.

On motion by Councilman Chinigo, seconded by Councilman Bartelloni to open the public hearing on Local Assessments for Curbs, Sidewalks for the Community Development Block Grant Oxford Terrace/Rutgers Place Phase III was unanimously approved.

ORDINANCE – 2ND READING –

Stephanie Evans, Borough Clerk read the title of Ordinance #18-20 into the record.

Ordinance #18-20 - BOND ORDINANCE TO AUTHORIZE THE ACQUISITION OF A NEW FRONT END LOADER FOR THE USE OF THE DEPARTMENT OF PUBLIC WORKS IN, BY AND FOR THE BOROUGH OF RIVER EDGE, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$160,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

Ordinance #18-20 was introduced by Councilman Papaleo, seconded by Councilman Bartelloni and unanimously approved at the September 4, 2018 meeting as follows:

BOROUGH OF RIVER EDGE ORDINANCE #18-20

BOND ORDINANCE TO AUTHORIZE THE ACQUISITION OF A NEW FRONT END LOADER FOR THE USE OF THE DEPARTMENT OF PUBLIC WORKS IN, BY AND FOR THE BOROUGH OF RIVER EDGE, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$160,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

BE IT ORDAINED by the Borough Council of the Borough of River Edge, in the County

of Bergen, State of New Jersey, as follows:

Section 1. The Borough of River Edge, in the County of Bergen, State of New Jersey (the "Borough") is hereby authorized to acquire new additional or replacement equipment and machinery consisting of a front end loader for the use of the Department of Public Works in, by and for the Borough. Said improvement shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$160,000 is hereby appropriated to the payment of the cost of making the improvement described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be met from the proceeds of the sale of the bonds authorized and the down payment appropriated by this ordinance. Said improvement shall be made as a general improvement and no part of the cost thereof shall be assessed against property specially benefitted.

Section 3. It is hereby determined and stated that (1) said purpose is not a current expense of said Borough, and (2) it is necessary to finance said purpose by the issuance of obligations of said Borough pursuant to the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law"), and (3) the total estimated cost of said purpose is \$160,000, and (4) \$8,000 of said sum is to be provided by the down payment hereinafter appropriated to finance said purpose, and (5) the estimated maximum amount of bonds or notes necessary to be issued for said purpose is \$152,000, and (6) the cost of such purpose, as hereinbefore stated, includes the aggregate amount of \$2,395 which is estimated to be necessary to finance the cost of such purpose, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 4. It is hereby determined and stated that moneys exceeding \$8,000, appropriated for down payments on capital improvements or for the capital improvement fund in budgets heretofore adopted for said Borough, are now available to finance said purpose. The sum of \$8,000 is hereby appropriated from such moneys to the payment of the cost of said purpose.

Section 5. To finance said purpose, bonds of said Borough of an aggregate principal amount not exceeding \$152,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 6. To finance said purpose, bond anticipation notes of said Borough of an aggregate principal amount not exceeding \$152,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issuance of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 7. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance and shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said bond anticipation notes shall be signed by the Mayor and by a financial officer and shall be under the seal of said Borough and attested by the Borough Clerk or Deputy Borough Clerk. Said officers are hereby authorized to execute said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 8. It is hereby determined and declared that the period of usefulness of said purpose, according to its reasonable life, is a period of fifteen years computed from the date of said bonds.

Section 9. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of said Borough, and that such statement so filed shows that the gross debt of said Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$152,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

Section 10. Any funds received from private parties, the County of Bergen, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of such purpose, shall be applied to the payment of the cost of such purpose, or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for such purpose shall be reduced accordingly.

Section 11. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

Section 12. The Borough intends to issue the bonds or notes to finance the cost of the improvement described in Section 1 of this bond ordinance. If the Borough incurs such costs prior to the issuance of the bonds or notes, the Borough hereby states its reasonable expectation to reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized by this bond ordinance.

Section 13. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the Borough, and the Borough shall levy <u>ad valorem</u> taxes upon all the taxable real property within the Borough for the payment of the principal of and interest on such bonds and notes, without limitation as to rate or amount.

Section 14. This ordinance shall take effect twenty days after the first publication thereof after final passage.

#18-294 Confirmation of Local Assessments for Curbs and Sidewalks for the Community Development Block Grant Oxford Terrace/Rutgers Place Phase III Project

WHEREAS, reconstruction of curbs and sidewalks on Oxford Terrace/Rutgers Place Phase III was completed; and

WHEREAS, the construction of new curbs and sidewalks are local improvements, the value of which is assessable to owners of the adjacent property; and

WHEREAS, Ordinance #18-04 authorized the construction of curbs and sidewalks as a local assessment to adjoining properties and such work has been completed; and

WHEREAS, the Borough of River Edge has received a grant from Community Development Block Grant for the construction of the curbs and sidewalks; and

Councilman Papaleo-said that he received a report from Liz Stewart and Jennifer Dougherty and was asked to share it with the Council. Fall tree planting is the process and Jennifer and Liz went out and purchased 205 trees with Grant money, bond money and Open Space funds. Margo Pohl and Liz Stewart drove around marking planting sites before letters are sent to the residents letting them know that trees are on the way. They still have about 1/3 of the sites to mark. Liz is coordinating planting with a landscaper for late October, early November. Shade Tree spoke with Michele Cariddi about coordinating their efforts for Cherry Blossom Park. Shade Tree continues to visit sites on a regular basis for residents requests regarding trees and they've visited 170 to date. Councilman Papaleo reported that Shade Tree continues to monitor their budget and they will encumber any unused funds to put towards stump removals. They are also looking to plant 5 purple blossoms, one in each park in memory of John Lynch. Councilman Papaleo was wondering where the Council is moving in this direction. Shade Tree has put in work orders for memorial trees currently in the park to be trimmed and pruned. A resident from Valley Road came to the meeting and explained that there are issues with the sewerage pipe because of trees and have had problems 3 times. The policy is if a tree is affecting the plumbing of a residents sewer system, it should be removed. He reported that the tree will be taken down. Councilman Papaleo stated that his wife was about 22, when her mother passed away from breast cancer and she passed 6 months after her father died. He said that this is something that has affected his family and also feels that regular checks are very important for all related cancers. He said that he has a male friend who has breast cancer and said that this is something men have to be concerned about too. Councilwoman Busteed-reported that the Green Team will have a shredder in the morning of October 7th at 9:00 a.m. in the cul-de-sac of Webb Avenue before River Edge Day and encouraged everyone to bring their paperwork for shredding. She reported that the Trex collection will continue through the end of September and encouraged everyone to visit the Environmental Protection booth at River Edge Day. They will unveil how they exceeded the collection amounts and what they plan to do with the bench and how residents can continue to recycle your plastics. She commended them for doing a fantastic job. She also reported that the River Clean-up is also scheduled in the morning of October 7th at KBG Park. She reported that Carolyn Baldanza, our new Rec Director has prepared what will not be a seasonal newsletter listing all the events that are going on and have occurred previously. Anyone who would like to get on her distribution list, should contact her. Councilwoman Busteed commended her for doing a great job with that. She reported that Stigma Free will be hosting a book club discussion at the Library on October 18th at 7 p.m. which will be moderated by a mental health professional and they'll be discussing the book "What Made Maddy Run". The book is about a girl who attended Northern Highlands and was a UPenn freshman who committed suicide. There are books available for free thanks to the PBA, Ambulance Corp and Fire Department and encouraged everyone to go to the Library to register and get their book. She thanked the River Edge Board of Education and administration of the River Edge Schools for inviting all of them to participate in their New Family Welcome Reception last week. There were probably 100 people or more, mostly new families that attended so it was really great to see their enthusiasm to be part of this wonderful community and she welcomed them all. Councilwoman Davis-reported that the Farmer's Market was cancelled last week because of the weather and tomorrow isn't looking much better. They've already had three vendors who have cancelled. She reported that the Health Department is having a meeting this evening and the next meeting for the

Municipal Alliance is tomorrow night. She also reported that the Fire Department has been very active. They've had 59 alarms during July and August; 2 structure fires and 11 mutual aid calls where we helped out other towns. One of which was a condo fire at Canterbury Village in New Milford. On September 13th to 15th many members attended the annual NJ State Firemen's Convention and during that time, any calls in River Edge, New Milford and Oradell were automatic tri-boro calls. She also reported that on September 20th, Chief O'Connell and Captain Cariddi attended a firefighter graduation ceremony which was held at Bergen Academies for Mica Gibson, Gary Wilhelm Jr., and Vincent Ciccolella who attained Fire Fighter I certification. All of them completed 168 hours of training and some used their summer vacations to do it so she commended all of them for their commitment. She reported that the Fire Department will not be participating in River Edge Day because they are covering for New Milford and Oradell who are taking part in the Northern Valley Chief's Parade which will be held on the same day. The antique engine from Company #2 will be leading the parade with two ex-fire chiefs serving as Grand Marshall's who have served for fifty years. Ex-Chief Dave Stucke will be driving the engine.

<u>Councilman Chinigo</u>-echoed everyone's comments on breast cancer. He reported that we have the Recycle Coach app up and running for the town. The app can be downloaded and is very easy and self-explanatory. You just have to put the zone you fall into and it gives you the option to set reminders which will remind you of garbage and recycling collections and also give changes to the schedule. He looks forward to receiving weekly reminders and said that everyone in River Edge can download it and its free to use until 2020. This is a program through a state grant that was just extended through 2020 and will give us a few years to try it out to see how it works. He feels that it's a nice tool and is pleased that we're able to offer something like this to our residents.

Mayor Mignone-echoed everyone's comments on the New Family Welcome Reception and explained that this is the third year that the school has done it and it seems to be very successful and very well received. Last Friday, the Mayor was asked to give welcoming remarks at the naturalization ceremony at New Bridge Landing. There were 23 citizens from 18 countries and the Mayor said that it's always very inspiring to see how emotional people become when taking the oath and become American citizens. He said that if anyone has the opportunity to go, it's a worthwhile event to attend. The Mayor stated that the League of Municipalities has been sending out many bulletins regarding the pending potential legalization of marijuana and are reaching out to all the towns to start thinking about how they are going to address this topic. They seem to think it's going to happen before the end of the year so it's not something that they really have a lot of time to work. He suggested that at a future work session they start to look at that. He received news that Rabbi Jacobson will not be renewing his contract with Temple Avodat Shalom next year as he will be moving back to Australia. He'll be here through June and the Mayor said that he's been a great help to him personally and was great at engaging all sectors of the community and will certainly be missed. In addition to getting screened for breast cancer, the Mayor made a personal recommendation that people get screened for skin cancer as he recently had a basal cell carcinoma removed. He said that it didn't look like anything and he never would have thought that's that what it was but his wife recommended that he have it looked at. The more he's mentioned it, he's found that the more people have had it so he feels that it's something that people should include in their regular health check-up. Councilman Papaleo questioned what the Council has planned for John Lynch, and the Mayor said that whatever they decide to do, he would like to see something permanent and significant. He said that John gave so many years of service to the Borough. The Mayor had originally thought about 140 Kinderkamack but found out that the park was already named in someone else's honor. He feels that they should advertise that and make more of an effort to identify the park by its rightful name because no one seemed to know that it was named for someone. Another thought he had was changing the name of Riverside Way. The only buildings that would be affected would be the Swim Club and the DPW building. You wouldn't have to worry about residents having to change their

address and it would be something significant and something that people will see and recognize as opposed to something more ceremonial in nature.

Councilman Papaleo-thought it was a great idea.

Councilman Gautier – agreed.

<u>Mayor Mignone</u>- said eventually they will come up with something for Council Acquafredda also. The Mayor reported that the River Dell Chamber of Commerce in cooperation with the Regional Chamber of Commerce are sponsoring a wounded warrior wedding in November. They've identified a needy military couple who are getting married and they are providing the wedding. The event will be held at the Venetian and is something that Virginia Korteweg has been championing for years. She was able to put it together with the cooperation of the other chambers and they are looking for people to attend. The Mayor will bring more information to the next meeting. The Mayor announced that they will be having a public presentation on the proposed Community Center at the next work session meeting.
