CALL THE MEETING TO ORDER –

On motion by Councilman Chinigo, seconded by Councilwoman Busteed to open the hearing of the public was approved unanimously.

CLOSE HEARING OF THE PUBLIC -

There being no comments by the public, the motion by Councilman Chinigo, seconded by Councilwoman Busteed to close the hearing of the public was approved unanimously.

COUNCIL COMMENTS –

<u>Councilwoman Kaufman</u>-stated that she doesn't know if we can do a community email for this but tomorrow night there's a vaping seminar at the River Dell High School Library at 7 p.m. She feels that it's important because vaping leads to lung problems, cancer and heart problems and people who vape are much more likely to become regular smokers.

<u>Councilwoman Busteed</u>-stated that she thinks the Board of Health has the ability to do community messages. She said that this is all over Facebook and through the schools emails so it's been highly publicized.

Councilman Papaleo-reported that he was not able to attend the last Beautification Committee meeting but he did speak with Michele by telephone. She advised him that they are moving forward with their spring activities and plantings. She said that they will have less meetings and use emails more to communicate with their members. He has been in contact with our new Superintendent, Jason Milito and congratulated him on his new post. Jason reported that the public spaces in the Borough have been blown out, thatched and seeded. He would like to make mention that the Foremen, Rick and Chris as well as the rest of the men are really working hard to get everything ready for the warmer weather months. Our residents should be happy with all of the work that they're putting in. Also Jason wanted him to make mention that Lisa and Cathy have been really great with him in helping him catch up things in the office now that he has taken over the post. He reported that he did attend the Shade Tree Commission meeting. They are interested in making use of Nixle as there is a community component to that. He was unsure at that time where to advise them to reach out so he told them to reach out to Carolyn who hopefully can give them further information. Councilman Papaleo also reported that they have met with the DPW and (inaudible) regarding the computer system that both the DPW and Shade Tree are hoping that they Borough will put into this years budget. He explained to them that they will be looking at the budget again because they had an unexpected bill from BCUA as well as other concerns. He announced that Arbor Day will be on April 26th. The Library will be receiving seedlings that they will be handing out to residents. There will be programs at Cherry Hill and Roosevelt Schools and they will also be reaching out to St. Peter's Academy during the day as well. Seedlings will be handed out to all three schools as well as bracelets for Arbor Day much like the Live Strong bracelet. They thanked the Mayor and Council and others for working hard to defeat the PSE&G Vegetation Act. They wanted to make mention that Liz Stewart went to Senator Paul Sarlo's office and was pleased with his willingness to work together. They discussed the inkind hours for the Commission which was greater than 5,400 hours which is about 400 hours per month. He said that one member has been on the Shade Tree Commission for 23 years, Liz has been on for 22 and is an arborist who provides that service to the Borough free of charge. Another member has been on for 21 years. They also wanted to convey to the Council that the program that they put together with the DPW over the last 23 years to proactively prune trees, has led to River Edge having far fewer downed trees, power lines and damage to homes then surrounding towns.

<u>Mayor Mignone</u>-asked Councilman Papaleo to reach out to Jason to make sure that we're ahead of the curve this year with getting the bathrooms reading for the opening days. We wait on SUEZ to put the water on so hopefully we can stay ahead of it.

<u>Councilwoman Busteed</u>-reported that at the Rec Commission meeting, Carolyn was told by DPW that the contract with Friendship House does not include the cleaning of the bathrooms of the fields and feels that there needs to be cleaning service provided for those. She said whether or not we want to amend with Friendship House or if there's another line that can be used......

Mayor Mignone-asked who did it before?

Councilwoman Busteed-replied, Bobbi used to do it and feels that it's not acceptable.

Mayor Mignone-suggested getting a cost from Friendship House.

On motion by Councilman Chinigo, seconded by Councilwoman Busteed to solicit a proposal from Friendship House for cleaning services for the ballfields and park was unanimously approved.

<u>Councilwoman Busteed</u>-mentioned that one of the Rec Commissions initiatives is to purchase and install exercise equipment at Memorial Park, whether it be static or otherwise. Carolyn has quotes and they will continue the conversation whether this is a priority for them. He asked that they speak with Ezio to see from a liability standpoint what would need to be considered. Carolyn is planning to have a conversation with him. Little League and REGAL are preparing for opening day, April 27th is the River Edge Run and you can sign-up now. They will do a major push starting April 1st to get registrations going. Carolyn held the first cultural affairs program at the Library which was a women's history presentation. It was a packed house and there were 41 senior citizens that attended. Carolyn had the opportunity to hand out a survey and is looking forward to getting those surveys back. She is working with Arlene Faustini on a health and wellness fair for seniors at the end of May. She reported that

Environmental Protection has been working on a mission statement and they have asked that she read their written and approved statement. It read as follows: "The River Edge Environmental Protection Commission provides leadership in bringing environmental best practices to River Edge, New Jersey and its surrounding communities by coordinating events, communicating with the public and staying current with global environmental practices. The Commission strives to improve recycling participation, increase support for Commission events and be a leader in our County and State for environmental awareness and support". Councilwoman Busteed applauds their effort to develop a statement to keep them focused on their goals. They will be working with the Hackensack Riverkeeper on a litter survey which is a very extensive project and be overseen by Montclair State. For anyone wishing to volunteer, the first training session is 8 hours and will be held on April 13th at the Johnson Library in Hackensack. The Environmental Protection Commission has provided 4 survey sites to the Hackensack Riverkeeper for their consideration to be part of the survey. We are hoping that this will help push the needle to us becoming Silver Award status for Sustainable New Jersey. Councilwoman Busteed congratulated the Green Team for receiving the BCUA \$3,000 grant for styrofoam recycling and she also thanked Lisa Hessman for working with Bonnie Stewart on that grant.

Councilwoman Davis-reported that she attended the Municipal Alliance morning meeting on March 28th where there were representatives from River Dell and River Edge school districts. She said that a lengthy discussion was held regarding the Alumni and Recovery Program and vaping presentation. She also attended an Alumni and Recovery Program on March 21st that they're trying to start up to raise awareness and also provide resources to the community about the disease of addiction. With regard to SCORE, Arlene Faustini had a Mardi Gras themed program which was very much appreciated. Carolyn, our Rec Director also attended. She reported that in the minutes from the January Board of Health meeting, Patty Cordts was named as President and Mary Clare Smith as Vice President. Jane Daly and Patty Cordts were appointed as River Edge representatives to the board of the Mid-Bergen Health Commission. She reported that the Farmer's Market update is not good. The farmer is not returning because they are expanding their store in Sparta and it will take all of their time this year. They'll try to find a new farmer, but if they don't get a new farmer, there's no Farmer's Market. Councilman Chinigo-reported that Little League Opening Day will be on April 13th and REGAL Opening Day is April 28th. He congratulated Ray Poerio for joining us as the new Borough Administrator, wished him good luck and looks forward to working with him. He also congratulated Jason Milito for becoming our new head of the DPW and looks forward to continued success with DPW.

PUBLIC COMMENTS -

<u>Susan Mitchell – 210 Kinderkamack Road</u> – expressed frustration regarding the New Bridge Landing Apartment project and the negative impact that it's having on all of the families surrounding that work site? She said that they have to call the Police every day because of traffic stoppages, not being able to get out of their driveways, pile drivers shaking the houses surrounding the site, etc. She complained that the Project Manager is not polite and said that the only support that they get is from the River Edge Police Department. They have been told that no one from the town is supervising this construction project. She wanted to make sure that they all know what's been going on next door. She attended all of the Planning Board meetings and she and many of the neighbors are throwing up their hands because they felt no one was giving them any support. When they realized construction was going to begin, she went to the Planning Office and asked who they could speak with if they have any concerns or issues so that they could be prepared. She was told that there is no one and if they have any problems they should call the Police Department. She is grateful to them for all the support that they've given them but feels that it's not really the way to utilize the Police Department. Although she doesn't live there, she's there every day calling the Police Department, she talks to the Project Manager and talks to the person throwing food on their property so that her parents don't have to. They haven't spent any money maintaining the outside of the home because of all of the dirt that's flying around. She said that the house is filthy on the outside. She said that there is trash in their yard and said that she has pictures to document everything that she is saying. One of the reasons she is here, is the same reason she went to see the Police Chief which is to thank him for his support and the support of his department. She also wants to get to know the people who are helping us. She feels like it's only going to get worse and the only two people she knows is Michelle and Joe. She thought it would be a good idea for the Mayor to

know first hand what's going on and said that she's not the only neighbor who feels this way. She wanted to let everyone know what's going on and the negative impact its having on the neighbors. Mayor Mignone-stated that on one hand, construction will always have impacts which cannot be avoided but he feels that she was not given the correct information. He said that there is a process to overseeing this. Anything regarding the building itself is under the purview of the Building Department. If there are any concerns about anything that's going on with the building, the Construction Official should be responding to that. We also have a Developer's Agreement in which the Borough Engineer is tasked with overseeing the site work.

Susan Mitchell-is that Robert?

<u>Mayor Mignone</u>-replied yes. Mr. Costa has the authority to make sure the site is clean and that they are following proper procedures. If there's any issues particularly with the foreman, he would be the first one who should be interacting with him.

<u>Susan Mitchell</u>-said "do you know how many times I've called him? I've stopped. I called him today and still didn't get a call back".

Mayor Mignone-said that he will be on the phone with him in the morning.

Susan Mitchell-said that Robert is a very nice gentleman.

Mayor Mignone-said, he is but he gets paid to do this.

Susan Mitchell-said that it's good to know because he's the first one to tell her that.

Mayor Mignone-explained that that's the way all projects are structured. The Mayor said that if there's issues with the dirt, they don't have the proper soil erosion protection measures in place because they should not be having soil and dirt flying off of the site. That is heavily regulated by the Bergen County Soil Conservation District and there is a separate permit for that. He said that he had been on Mr. Costa a number of times because he saw that the street was a mess. The Mayor said that he is very concerned because obviously there has been a break-down in the process, but there is a process. He apologized that it has gotten to this point but assured Ms. Mitchell that he will speak with Mr. Costa first thing in the morning.

<u>Susan Mitchell</u>-said that if he does speak with him, to tell him that the reason she called him today is regarding the retaining wall. She said that a section has become dislodged and is concerned because it is very close to the property line.

<u>Mayor Mignone</u>-said that he doesn't know if the Police Department are giving summonses but he feels that they should if they are blocking traffic, keeping debris in the road or whatever it may be.

<u>Susan Mitchell</u>-said all these little things happen every single day and it adds up. It's not like there's one huge violation but she's talking about quality of life issues. She again said that the Project Manager is very rude and very aggressive and she's sure that he feels the same about her but a lot of that comes from being defensive because she's very protective of her parents.

Mayor Mignone-said that they're in our town so they should be respectful.

Susan Mitchell-said that Peter, the Project Manager is not.

Mayor Mignone-again said that he will speak with Mr. Costa tomorrow.

<u>Susan Mitchell</u>-asked how she can follow-up and make sure that the line of communication is open and that he understands what's going on. She would like to be able to reach out to him.

Mayor Mignone-offered his cell phone number.

<u>Susan Mitchell</u>-said that she would be happy to share hers as well.

<u>Councilman Chinigo</u>-asked if she would come back to the next meeting and let them know if anything has improved? We can't do anything for you if we don't know about it.

<u>Susan Mitchell</u>-said that Michelle and the Chief encouraged her to come and she feels that the previous administration had let them down. She thanked them for their time.
