THE BOROUGH OF RIVER EDGE ORDINANCE NO. 19-20

AN ORDINANCE OF THE BOROUGH OF RIVER EDGE, COUNTY OF BERGEN AND STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 400 "VEHICLES AND TRAFFIC" ARTICLE II "PARKING, STANDING AND STOPPING".

WHEREAS, the Mayor and Council has deemed it in the best interest of the public health, safety and welfare to supplement, amend and revise its Vehicles and Traffic Ordinance as codified in Chapter 400 of the River Edge Borough Code to provide for angle parking along Bogert Road from Howland Avenue to Reservoir Avenue; and

WHEREAS, Article II, §400-10, entitled "Angle parking" provides for angle parking in all commercial parking yards and parking places open to the public or to which the public is invited situated within 100 feet of the center line of Kinderkamack Road in the Borough of River Edge from Main Street to Voorhis Avenue, and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of River Edge, County of Bergen and State of New Jersey as follows:

SECTION 1. §400-10 is hereby amended and supplemented by the addition of the following section:

Angle parking shall be permitted upon the following streets, portions of streets or designated points:

SECTION 2. Except as set forth in Sections 1, the balance of Chapter 400 shall not be affected by this Ordinance.

SECTION 3. This chapter is intended to supplement existing ordinances and other laws pertaining to Chapter 400, entitled "Vehicles and Traffic" of the River Edge Borough Code and shall not be construed to excuse any person from complying with such other ordinances and laws.

SECTION 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5. If any part, sections, provisions, or total of any of the aforementioned sections are held to be invalid or unenforceable by any court, the findings or judgments of which court are applicable in the State of New Jersey, that the balance and remainder of such sections shall remain

in full force and effect as an Ordinance of the Borough of River Edge.

SECTION 6. This Ordinance shall become effective immediately upon adoption and publication according to law.

PUBLIC COMMENTS-

On motion by Councilman Papaleo, seconded by Councilwoman Davis to open public comments was unanimously approved.

<u>Casey Connors-259 Adams Avenue</u>-commented that the ramp at Sixth and Continental still isn't right and explained how they should be constructed.

<u>Raymond Poerio</u>-said that this is one of the ones that we had on the list. There were 7 or 8 that were brought to his attention that were the priority but they can't do all of them at one time. He said that the ramp at 6th and Continental is one of the items that has been given the go ahead to be addressed. <u>Casey Connors</u>-said that another one that is at the top of the list is Adrian Way and Millbrook Road. <u>Councilwoman Davis</u>-said yes, it's on there.

<u>Raymond Poerio</u>-said that the Council has conveyed to him that this is a priority and needs to be addressed. He explained that there are 4 of them that they have available funds to do. He read the names of the streets that are the priorities as follows: Millbrook and Adrian, Elm and Tenney, Millbrook and Adams and Jefferson and Fifth. As he said in work session, he's put together a plan to go ahead and start some of these immediately and the balance of them, including Continental would be part of next years capital plan.

<u>Casey Connors</u>-he complained that there are sidewalks on Webb or Wales that go down to Kinderkamack that have to be removed.

Raymond Poerio-asked why?

<u>Council President Busteed</u>-asked if they are the cobble stone streets? She asked if they are historically designated?

Councilwoman Kaufman-replied, yes.

Casey Connors-said it doesn't matter, stairs are not allowed in the middle of the sidewalk.

Raymond Poerio-said he will do some research on that.

Casey Connors-said that he's been complaining for 20 years.

Councilwoman Kaufman-said that we're trying and feels that it's good news.

<u>Raymond Poerio</u>-said that the important part is that they've laid out a plan. Although he doesn't know the whole 20 year history, he told Mr. Connors that this Council has made it a priority and have asked him to go ahead and address it.

<u>Cindy Bequeaith-745 Seventh Avenue</u>-said that she had submitted a letter requesting a block party and may need to change the date. She asked what she will have to do?

<u>Councilwoman Busteed</u>-said that the Clerk has the authority to approve block parties so she should go through the Clerk.

<u>Cindy Bequeaith</u>-said that she read an article in the newspaper stating that the Mayor had not turned in a resignation. She asked for an explanation or procedure of what's happening now and how they will go forward?

<u>Tom Sarlo, Esq.</u>-stated that until the Mayor turns in his resignation, he's still the Mayor. He still owns a house here and he believes that there are one or two projects such as the transit project that he still wanted to stay involved in because it was near the end of completion. He believes that the Council had asked him to try and stay involved in that. Once he turns his resignation in, there's a process by law to fill his term for the remaining year.

<u>Cindy Bequeaith</u>-asked if there is a down side to him not actually being present in the room? <u>Tom Sarlo, Esq.</u>-explained that the form of government that you have here is a weak Mayor form of government where really the Mayor has no power, it's a strong Council. The Mayor doesn't have a vote unless it's a tie breaker. He said that there is really no down side. It's almost like the Mayor took a two week vacation and went out of state, there's a process in place where Councilwoman Busteed steps in as Council President. Even if he resigns, it's the same process. The Borough continues existing as all the department heads report to the Borough Administrator who then reports to the Council.

Cindy Bequeaith-asked if there is a target date or could this go on?

<u>Tom Sarlo, Esq.</u>-said that he doesn't know and doesn't want to speak for him. He feels that it's a benefit to the Borough to keep him involved with the transit project because of his engineering background. <u>Casey Connors</u>-asked what the summer hours are for Borough Hall.

<u>Stephanie Evans</u>-replied that regular hours except for the summer are 8 to 4. During July and August it's 8 to 4 Monday to Thursday and Friday 8 to 3.

<u>Cindy Bequeaith</u>-feels that there needs to be more care taken at the beginning of the July 4th parade because many of the participants were not listening to instructions and parked in the middle of the street which made it difficult for anyone to get through in case of an emergency.

Casey Connors-asked how soon did they know they were going to have a closed session?

Raymond Poerio-said during the past day or two.

<u>Casey Connors</u>-feels that the meetings and times should be listed somewhere.

<u>Raymond Poerio</u>-said that we can accommodate the start component of that, but the regular session time you don't know because you don't know how long the closed session will take.

On motion by Councilwoman Davis, seconded by Councilman Papaleo to close public comments was unanimously approved.

COUNCIL COMMENTS -

Councilwoman Davis-reported that the Ambulance Corp. has had 436 calls this year. For the month of July they've had 69 calls; 38 medical, 15 traumas, 8 motor vehicle, 6 overdoses and they helped out on 2 fire calls. They also responded in Oradell twice and New Milford once. She reported that the Fire Department has had 178 alarms year to date; 40 alarms in July and three drills. They had one meeting, 2 structure fires, a cooking fire, natural gas, carbon monoxide, odor of smoke, activated fire alarms and brush and rubbish. They also responded to mutual aid calls in Oradell and New Milford. They were very busy with smoke alarms and carbon monoxide alarms sometimes at 3:00 in the morning. Councilman Papaleo-reported that he is in regular contact with Jason at the DPW. He also reported that there was an issue with rats in town between Concord and Manning. They brought in an exterminator who baited traps and has been there regularly and met with residents. There has been very little bait taken which means it's not an infestation. Our Superintendent of Public Works has directed the exterminator to continue through the end of August even though they thought the issue was resolved. He reported that the front loader that was ordered through capital is due to come in during the next few days and will make a big difference because they will use it all year long. He reported that the road repavements finished about two weeks ago and they did a great job but they still have striping to do. Our new jet vac, which we use on our storm drains to make sure that flooding does not occur in town, is another piece of equipment that we use all year round and should be coming in within the next month or so. The Borough air conditioning has been repaired and as the Borough Administrator had reported, the Library HVAC had an issue and the downed unit should be replaced by Wednesday. He thanked DPW workers for the phenomenal job they've done in maintaining our lawns and properties throughout the summer and also thanked Beautification for doing a beautiful job here at Borough Hall as well as other locations. He knows that the Beautification Committee wants to offer a special thanks to DPW for their responsive and supportive nature in helping out. He said that Shade Tree also wanted to extend their thanks to DPW for all that they do to support them.

<u>Councilman Gautier</u>-echoed Councilman Papaleo's sentiments. The DPW and Beautification Committee have been doing a wonderful job on a number of projects and wanted to let them know it's very much appreciated.

Council President Busteed - congratulated Carolyn Baldanza, the Recreation Camp Staff and all of the

Counselors for another successful record breaking attendance year for the summer playground program. They added some new things to the program this year including trips to the Swim Club which were very much appreciated by the campers and parents alike. She again thanked everyone for their hard work and doing a great job in providing a fun, safe environment for the River Edge children. She also thanked Cindy Bequeaith for helping with the July 4th parade. Council President Busteed reported that the Environmental Protection Commission and Green Team continue to work throughout the summer. We completed our commitment to the Hackensack Riverkeeper litter survey that they're doing in coordination with Montclair State. We went out and surveyed in New Milford, by Palmer Brothers and down Gates Avenue. Council President Busteed participated personally and within 30 minutes they collected over 150 cigarette butts, one of the largest polluters of our waterways and something that does biodegrade at all. She explained that the filters are more of a problem than plastic straws. She did bring to the EPC and Green Team, Terocycle which does unique recycling and does have cigarette butt receptacles which they are considering asking the DPW to hang one down at KBG. Although that area is a smoke-free environment, cigarette butts are the largest item that is collected during the river clean-up and she feels that encouraging people to deposit their butt in a little receptacle, would keep those things out of the waterway. She met with OEM Coordinator Starace today and wanted to share statistics regarding Nixle. In one year we've gone from 1,700 registered users to 2,500 registered users which exceeds Nixle's average rate of 10%. She said that the tax stuffer will have very clear directions on how to get residents to register for Nixle and encourages everyone out there listening to register for Nixle. Director Starace is doing a very good job in getting advisories out and he has offered to send out advisories for any borough departments. She wanted to comment on the recent ordinance that Oradell passed regarding the fee implementation. They sent us a certified letter stating that they were planning to start enforcing that ordinance on August 8th. We had gone to one of their meetings asking them very strongly to rescind the ordinance because we felt that it was unfair that they would charge Oradell residents a \$5.00 participant fee and non-residents a \$75.00 participant fee. They put a three month moratorium on the enforcement, however, they have notified us that they plan to start enforcing it. She wanted to set the record straight that our Borough Administrator, at the Council's request, has made several overtures with their Borough Administrator to sit down with them as professionals to understand what fee issues they have regarding their facilities. They have rejected the offers to have those conversations and she just wanted to have the record be clear that our Borough Administrator and Recreation Director stand ready to meet with the appropriate parties in Oradell to have these conversations. She said that we are not ignoring any request to meet, however we feel that these are the appropriate parties. We're sad that they've decided to enforce the ordinance, but that is their ordinance to enforce, not ours.

Cindy Bequeaith-asked for an explanation as to what the ordinance is?

<u>Council President Busteed</u>-explained that they passed an ordinance last November that required certain classes of participants, Classes 1, 2 & 3 to pay to register with the Borough of Oradell as either and Oradell resident or non-resident. Oradell residents would be charged \$5.00 a year to participate and use their fields and non-residents would be charged \$75.00.

<u>Cindy Bequeaith</u>-asked if that is per person?

<u>Council President Busteed</u>-replied, per participant. So if you have 5 children you would pay \$375.00 annually.

Councilwoman Davis-stated that the teams are River Dell teams.

<u>Council President Busteed</u>-said that our position was very clear and she wanted to go on the record that they have notified us that they now are enforcing it and our position has not changed. Our professionals are ready to meet with their Administrator at any time.

<u>Councilwoman Davis</u>-stated that right from the beginning, several members of our Council and the Mayor went up and spoke with them at a meeting.

<u>Councilman Gautier</u>-agreed and stated that the Mayor and Council members expressed their dismay over this ordinance at the Oradell Mayor and Council meeting.
