SECTION 2. The improvement and purchases are authorized as follows:

- a. Repairs and improvement to public buildings and grounds,
- b. Repair and improvement of the elevator in the Public Safety Building.

SECTION 3. The appropriation shall be made from the General Capital Fund and no debt is authorized.

SECTION 4. This ordinance shall take effect immediately after the first publication after final passage as provided by law.

THE BOROUGH OF RIVER EDGE ORDINANCE NO. 19-20

AN ORDINANCE OF THE BOROUGH OF RIVER EDGE, COUNTY OF BERGEN AND STATE

OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 400 "VEHICLES AND TRAFFIC" ARTICLE II "PARKING, STANDING AND STOPPING".

WHEREAS, the Mayor and Council has deemed it in the best interest of the public health, safety and welfare to supplement, amend and revise its Vehicles and Traffic Ordinance as codified in Chapter 400 of the River Edge Borough Code to provide for angle parking along Bogert Road from Howland Avenue to Reservoir Avenue; and

WHEREAS, Article II, §400-10, entitled "Angle parking" provides for angle parking in all commercial parking yards and parking places open to the public or to which the public is invited situated within 100 feet of the center line of Kinderkamack Road in the Borough of River Edge from Main Street to Voorhis Avenue, and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of River Edge, County of Bergen and State of New Jersey as follows:

SECTION 1. §400-10 is hereby amended and supplemented by the addition of the following section:

Angle parking shall be permitted upon the following streets, portions of streets or designated points:

SECTION 2. Except as set forth in Sections 1, the balance of Chapter 400 shall not be affected by this Ordinance.

SECTION 3. This chapter is intended to supplement existing ordinances and other laws pertaining to Chapter 400, entitled "Vehicles and Traffic" of the River Edge Borough Code and shall not be construed to excuse any person from complying with such other ordinances and laws.

SECTION 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5. If any part, sections, provisions, or total of any of the aforementioned sections are held to be invalid or unenforceable by any court, the findings or judgments of which court are applicable in the State of New Jersey, that the balance and remainder of such sections shall remain in full force and effect as an Ordinance of the Borough of River Edge.

SECTION 6. This Ordinance shall become effective immediately upon adoption and publication according to law.

This AGREEMENT was made as September 9, 2019, between the BOROUGH OF RIVER EDGE in the COUNTY OF BERGEN, STATE OF NEW JERSEY, and the CITY OF HACKENSACK in the COUNTY OF BERGEN, STATE OF NEW JERSEY

RECITALS

WHEREAS, Rugova Restaurant is a restaurant located within the Borough River Edge at 250 Johnson Avenue; and

WHEREAS, Rugova Restaurant has a sewer connection which services the premises located at 250 Johnson Avenue, River Edge, New Jersey and the sewer facilities are owned by the City of Hackensack; and

WHEREAS, the City of Hackensack and the Borough of River Edge are desirous of entering into an Agreement for compensation to be paid by the Borough of River Edge to the City of Hackensack for the sewerage flow from Rugova Restaurant into the Hackensack sewerage facilities.

NOW THEREFORE, in consideration of the mutual terms and conditions contained herein, the undersigned parties agree as follows:

- 1. <u>SCOPE OF SERVICE</u>: The City of Hackensack does hereby agree to accept the sewerage and effluent flowing from Rugova Restaurant located at 250 Johnson Avenue, River Edge, New Jersey.
- 2. <u>COMPENSATION</u>: In consideration of the City of Hackensack's acceptance of sewerage flow from Rugova Restaurant into the sewerage systems and facilities of the City of Hackensack, River Edge does hereby agree to the City of Hackensack the following payment schedule over the next (5) years.
- 2019 \$600.00 2020-\$800.00 2021-\$1000.00 2022 -\$1200.00 2023-\$1400.00 per year, during the term of this Agreement payable in advance with in the first thirty day of each calendar year.
- 3. <u>TERMS OF AGREEMENT</u>: The terms of this Agreement shall retro to commence on January 1, 2019 and terminate on December 31, 2023. The parties do hereby agree to enter negotiations for the extension of the within Agreement for an additional term prior to expiration of

this Agreement at a charge which shall be deemed fair and reasonable to the parties hereto. Should the Borough no longer need the service it reserves the right to cancel this agreement with 30 days' notice.

PUBLIC COMMENTS -

On motion by Councilman Chinigo, seconded by Councilwoman Davis to open for public comments was unanimously approved.

Officer Patrick Diamond-President PBA Local 201- said that he is here representing 24 officers and ranking officers of the River Edge Police Department. He also recognized borough employees and members of Local 108 which represents the River Edge Department of Public Works who are in attendance tonight. He said that they're here tonight to speak about the current state of the Borough. While both labor unions are currently in negotiations with the borough, he wanted to take a minute to raise the following points. In 2010 the borough went in to dire financial straits after a down turning economy, reduction of state aid and the purchase of two properties, one known as Cherry Blossom Park and the former American Legion building which has recently become a new parking lot. The perfect storm resulted in borough employees taking 120 hours of furlough time in one year and 48 hours the next year. We were one of the only towns in Bergen County that instituted furlough time. Furlough time was not accepted by contractual employees and were threatened with layoffs of four police officers in our union. On top of that, we were given raises of 0% for the years 2010 and 2011 and contracts that were massively gutted and not comparable to any town in Bergen County let alone our neighborhood towns. Former Council members answer to that was "well you agreed to it". They were right, except it was under the premise of layoffs which he is not sure would have been the case and after the fact seemed to be more of a threat and not a promise. In the interim all three divisions of labor in this town, the Police Department, Public Works and borough employees have lost many employees to other towns for more comparable contracts and comprehensive benefits than what we are offered here in River Edge including vision and dental care that our members do not get. The Police Department alone has lost ten members to other departments which leads to a constant state of teaching, training and loss of experience to the borough and its residents. Fast forward to 2019. The borough has regained its footing with the surplus of funds for emergencies, the borough has gotten through multiple budget sessions that has tightened the capital improvement programs. What has remained constant is the budgets of employees of this town, who are constantly praised by the residents and this Governing Body, were strong armed into when times were tough and have not changed when times have improved as seems to be the case at this time. Now in 2019 we are looking at the prospect of having an additional borough owned building which will have to be maintained. A building that since the beginning as gone through an identity crisis. First it was going to be for senior citizens who seemed to be happy with the Temple at a reasonable cost, then it was going to be a rain location for camp

which later determined would not have the capacity due to our well-run summer program. The idea of having a place for teens to hang out has also been floated but it seems that the activities would be limited due to the size of the space. Last, it was to be used for organizations to have meeting space and was also said that the Recreation Director would plan additional programming. Yet when pressed by concerned residents about future programming costs to use, the answer in short has been "if we build it they will come" without any concrete answers or plans. In talking about meeting space, he wanted to mention that council chambers if frequently available along with the public safety meeting room across the hall, the court room, the meeting space at Company #1 as well as the Library. They all are borough owned buildings and should have no different insurance than the use of a proposed community center would be. The spaces may very well accommodate the organizations in need of space that don't know they are available to them. As far as a teen center, he was told that River Edge had attempted a teen center in the early 2,000's which was held at the First Congregational Church on Friday nights. After a few years of programs, attendance lacked and the idea fizzled out. The community center had an additional price tag of \$2.6 million dollars. Since the projects inception, prior work order changes and building re-designs, there have been projections that the project will be over \$3 million dollars for approximately 6,500 square foot building and a maximum capacity of less than 300 people. There stands to be dissension among residents on the need to spend such a large sum of money of what is ultimately being delivered. From the employee view, while the borough infrastructure is in need of upgrades including technology, communication and roadways, the borough is moving full steam ahead on the project that is estimated to be over \$2.6 million dollars. We ask that we take our concerns into account as we move forward. The project seems to be more of a luxury while many aspects of the borough's responsibilities are underfunded. He thanked them for their time, consideration and attention. He also thanked all of the employees who came out tonight and all that they do with this lovely town on a daily basis. Chris Tabor, Shop Steward for DPW Local 108 – he is speaking on behalf of the union employees working at the Department of Public Works in the Borough of River Edge. We are members of R.W.D.S.U. UFCW, 1.3 million strong. The President of Local 108, Charles Hall is with us today. He said he wanted to take this opportunity to provide the Council with some history of our collective bargaining with the borough. We are very concerned about our current collective bargaining agreement that was modified in 2010 which was a difficult period across the state including the Borough of River Edge. The agreement had many give backs but the one specific concern was the wage appendix for salary steps. The way the steps are outlines, effects the growth of pre-2010 employees and puts employees hired thereafter in the annual wage which is not competitive to the job titles in the DPW. In fact, the wage scale in the DPW is near the bottom compared to other municipalities in the country and other surrounding towns. Since 2010 the town has constantly reduced benefits from their employees but seem to find funding for all types of projects. We believe some of these projects are not popular with the citizens of the borough. Now one of the largest and most costly projects to the taxpayers has been started and it seems to have no direction or actual purpose yet. We believe that this project needs to be more thought out to serve the residents better and to be put on hold until the borough fixes its current infrastructure and its employees contracts. Other towns that have had layoffs have either paid employees back for the time lost or have given back throughout new contracts. River Edge has not. Our research shows that River Edge Department of Public Works has the highest number of step to top pay, 32 years. It could be up to 64 years if a Laborer decides to switch to a titled position. That would be 32 steps per title which would take 64 years to get to top pay. Also, the Laborer position is one of the lowest paid in Bergen County topping at \$58,000 up to 32 years of service. Most employees will retire before they reach top scale. We have looked at other contracts and the average number of steps is 9 and the average salary is \$75,000 for a Laborer. As you can see River Edge's steps for top pay is well below the norm. The State of New Jersey has recognized how expensive it is to live in New Jersey and have put average workers on track to \$15.00 an hour. We at DPW are skilled workers who serve this community. All that the employees are asking for is that the borough start working

towards giving back to the people that keep this town great and go above and beyond their duties for the residents of this town. This town is one of the safest, best plowed and cleanest towns in Bergen County and that's because of the hard working employees of River Edge.

Nancy Kennedy – 220 Manning Avenue-feels that the Council is at a crossroads. She feels that they have opportunities and you can either make this town a really great place or make people like her, move out. She received her tax bill this year which was quite a hefty raise. She was told that Cherry Hill is contemplating an addition. Why, because we've put in high density housing. We now have all these apartments coming in, so now we have more students and the state mandates that you have to have so much space per student. We want our properties to continue to be valuable because that's what attracts people to the town. You know that coming the road, we the taxpayers are going to have to pay for an addition to the schools and now we have sort of stormy clouds coming. She said that people are talking about a recession and when recessions happen, budgets go down. She again feels that they are at a crossroads because right now they have lovely parking lot and they haven't gone out to bid for this building which is millions of dollars. They've never put it to a referendum, they've never asked people and just sort of shoved it at us and basically said "you elected us, done deal, too bad". She feels that they should hold off to see what happens because if we go into a recession, people aren't going to be able to afford this. What's going to happen next year because the tax increase this year was quite a shock. She said it's too high and feels that it's only going to get higher. She said that if they had the money put aside, they should keep it for the lean times coming because she feels not only in River Edge, statewide and throughout the country, we're heading into rough weather and we should keep our powder dry.

On motion by Councilman Gautier, seconded by Councilman Chinigo to close public comments was unanimously approved.

COUNCIL COMMENTS -

Councilman Gautier-reported that the Library was pleased that the site work was not too disruptive to the Library and their operations and in fact they had record breaking attendance and participation in the summer reading program which should be commended. He was notified that they have been bequeathed \$10,000. He also reported that they have concerns about their HVAC system. They have 4 units right now. 1 was replaced this year, 3 are older so they're concerned that next year 1 or 2 may go down as well. He said that the Library Board would like set up a meeting with the sub-committee of the community center and possibly become a part of that sub-committee.

<u>Councilman Papaleo</u>-said that being a teacher and having had a student who lost his father in 9/11, he wanted to remind our residents that we will be having a memorial service in front of Borough Hall at 6 p.m.

Councilwoman Davis-said that she spoke with Carol Mah who in charge of the seniors at the Temple about the new contract for the coming year. She said that it ended up working out pretty well last year so they weren't going to argue about anything. The main holidays for the Temple were not on a Monday or Tuesday so it didn't affect them and they were happy about that. She reported that the Ambulance Service has responded to 491 calls so far this year. For August there were 63 calls; 34 medical, 10 falls, 10 motor vehicle accidents, 6 combination of psych overdose and intoxication, 2 injuries, 1 choking. They took patients to Hackensack 17 times, Pascack Valley 8, Holy Name 8, New Bridge 7, Valley 7 and Englewood 2 and they responded to Oradell twice. She reported that the Fire Department responded to 26 alarms for the month of August. They had 2 drills, 1 meeting, a cooking fire and carbon monoxide and smoke alarms. They also visited Grace Lutheran Church during their Day Camp to teach them fire prevention.

<u>Councilman Chinigo</u>-thanked everyone for coming in. He said that they've heard them but are not allowed to comment with ongoing negotiations but they were heard and they've listened. He reminded everyone that school is back in session and encouraged everyone to drive carefully. During the summer

with less cars on the road people tend to drive a little faster so again asked that everyone remember that we have young children around town and to be a little more cautious. He thanked Ed Mignone and his family for all that he did, their sacrifices and again wished them luck. He also reminded everyone that River Edge Day is right around the corner on October 6th and hopes to see everyone there.

Councilman Gautier-said that although they cannot comment on collective bargaining at this time, he believes that the best solutions are collective solutions and hopes that they can come to a mutually beneficial compromise.

Council President Busteed-thanked all of the individuals who had their hand in running the 2nd Annual Teen Night that was held in River Edge this year. She said many members of our Police Department were instrumental and she's heard wonderful things about how organized it was, especially from a police standpoint. She thanked Carolyn Baldanza for introducing new activities for the over 300 kids that attended. She alerted the Council that Brandon Cho will be working on his Eagle Scout project to repair the boat shed and she wished him the best of luck. Council President Busteed said that Superintendent Milito is aware of the project and she will invite Brandon to come before the council when the project is finished. As Councilman Papaleo mentioned, Dick Berry has agreed to organize the September 11th observance which will be held on the 11th in front of Borough Hall at 6 p.m. In case it rains, the ceremony will move to the Council Chambers. She invited everyone to come out and remember everyone who was lost especially our 5 residents and honor the first responders who heroically went in for days, weeks and months and are now suffering terrible health consequences as a result. Finally, she informed everyone that the Green Team Chairperson, Bonnie Stewart has submitted our renewal for Sustainable New Jersey and said that she submitted the highest number of points and hopes that we will attain Silver status. She thanked the borough employees and bargaining units who came and spoke with us tonight and said that they appreciate their comments and looks forward to ongoing conversations.
