## BOROUGH OF RIVER EDGE ORDINANCE #23-2

## AN ORDINANCE TO AMEND CHAPTER 206 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVER EDGE, ENTITLED FEES.

BE IT ORDAINED by the Mayor and Council of the Borough of River Edge that the following amendments to Section 206-2 entitled "Schedule of Fees" are hereby approved:

<u>Section 1.</u> Subsection L shall be amended by the following:

## Delete:

Police outside duty: \$135 per hour. L.

## Add:

L. Police outside duty:

- (1) For commercial entities and utility companies-\$135 per hour with a 4-hour minimum
- (2) For all other entities \$135 per hour

Section 2. Subsection EE shall be amended by the following:

Delete:

Variance applications

\$300

(3 or fewer variances)

Bulk variances \$300 for an application requesting three or less variances,

and an additional \$150 per variance for each variance application requesting more than three variances.

Use variances An application of \$1000, a minimum of \$1,500 in escrow

Each additional variance over 3 \$150

Add:

Variance applications \$350

(3 or fewer variances)

Bulk variances \$350 for an application requesting three or less variances,

and an additional \$200 per variance for each variance application requesting more than three variances.

Use variances An application of \$1500, a minimum of \$2,000 in escrow

Each additional variance over 3 \$200

Legal Escrow \$450

Section 3. Subsection LL shall be created with the following:

Land Use Board – Planning (Commercial) Fees:

(1) Application Fee \$500

(2) Escrow Fees:

Minor Site Plan: For development application where the square footage of the building(s)

is not greater than 3,000 sq. feet.

Engineering Escrow \$2,000 Legal Escrow \$1,500 Planner Escrow \$1,000

Major Site Plan: For development applications where the square footage of the

building(s) is in excess of 3,000 sq. feet. Engineering Escrow \$5,500 Legal Escrow \$3,000

Planner Escrow

\$3,000

Minor Sub-Division: For development of three or less lots as defined by Borough

Ordinance

Engineering Escrow \$2,000 Legal Escrow \$1,000 Planner Escrow \$1,000

Major Sub-Division: For development of more than three lots as defined by Borough

Ordinance

Engineering Escrow \$5,000 Legal Escrow \$3,000 Planner Escrow \$3,000

Use Variances:

Engineering Escrow \$2,000 Legal Escrow \$2,000 Planner Escrow \$2,000

<u>Section 4.</u> Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

<u>Section 5.</u> In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 6. This Ordinance shall take effect immediately upon final passage and publication as required by law.
