ORDINANCE #24-24

AN ORDINANCE AMENDING AND SUPPLEMENTING THE REVISED GENERAL  
ORDINANCES OF THE BOROUGH OF RIVER EDGE,  
CHAPTER 400, "VEHICLES AND TRAFFIC"

BE IT ORDAINED by the Mayor and Council of the Borough of River Edge that the following amendments to are hereby approved:

Section 1. Section 400-11, entitled "Parking of trucks and commercial vehicles" of Article II entitled "Parking, Standing, and Stopping" shall be replaced with the following:

§ 400-11 Parking of trucks, taxis and commercial vehicles.

- A. Overnight parking of trucks on any streets in the Borough between the hours of 12:00 a.m. and 6:00 a.m. is hereby prohibited.
- B. There shall be no parking of commercial vehicles, buses or trucks with commercial plates on any street within the Borough of River Edge during any hour of the day or night, except when the owner or operator is actually engaged in business or performing services.
- C. The overnight parking of vehicles registered as a taxi, limousine, omnibuses, medallion, or dealer is prohibited on all streets within the Borough between the hours of 12:00 a.m. and 6:00 a.m.

Section 2. Section 400-27, entitled "Schedule I: Parking Prohibited" of Article IV entitled "Schedules" shall be amended with the following:

Section 3. Section 400-30, entitled “Schedule IV: No Stopping or Standing” of Article IV entitled “Schedules” shall be amended with the following:

**Add:**

<b>Name of Street</b>	<b>Sides</b>	<b>Location</b>
Bogert Road	East	From a point 205 feet south of Howland Avenue to a point 195 feet north of Howland Avenue
Bogert Road	West	From a point 135 feet south of Howland Avenue to a point 230 feet north of Howland Avenue

Section 4. Section 400-30, entitled “Schedule VII: Stop Intersections” of Article IV entitled “Schedules” shall be amended with the following:

**Add:**

<b>Stop Sign On:</b>	<b>Direction of Travel:</b>	<b>At Intersection of:</b>
Mercer Avenue	North	Wayne Avenue
Lafayette Avenue	North	Wayne Avenue

Section 5. Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

Section 6. In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 7. This Ordinance shall take effect immediately upon final passage and publication as required by law.
