RESOLUTION NO.

ADOPTING THE HOUSING ELEMENT AND FAIR SHARE PLAN

WHEREAS, N.J.S.A. 40:55D-28 provides that a Municipal Land Use Board may prepare and, after public hearing, adopt or amend a Master Plan or component parts thereof, to guide the use of lands within the municipality in a manner that protects public health and safety and promotes the general welfare; and

WHEREAS, the Borough of River Edge Municipal Land Use Board adopted its current Master Plan, pursuant to N.J.S.A. 40:55D-28, on July 26, 1984; and

WHEREAS, N.J.S.A. 40:55D-28(b)(3) requires that the Master Plan include a Housing Element including, but not limited to, residential standards and proposals for the construction and improvement of housing; and

WHEREAS, the Mount Laurel Doctrine establishes a constitutional obligation that requires municipalities to address their ofair shareo of affordable housing; and

WHEREAS, the New Jersey Fair Housing Act, <u>N.J.S.A.</u> 52:27D-310, requires that a Housing Element be designed to achieve the goal of access to affordable housing to meet present and prospective housing needs, with particular attention to low- and moderate-income housing; and

WHEREAS, the Municipal Land Use Board adopted a Housing Element and Fair Share Plan (õHEFSPö) on July 25, 1988; and

WHEREAS, pursuant to <u>In re N.J.A.C. 5:96 and 5:97</u>, 221 N.J. 1 (2015) (Mount Laurel IV), on July 7, 2015, the Borough filed a Declaratory Judgment action in Superior Court of New Jersey, Law Division seeking, among other things, a judicial declaration that its HEFSP, to be amended as necessary, satisfies its offair shareo of the regional need for low- and moderate-income housing pursuant to the Mount Laurel Doctrine; and

WHEREAS, in furtherance of the Declaratory Judgment action, the Borough and Fair Share Housing Center (õFSHCö) engaged in good faith negotiations, which resulted in a Settlement Agreement between the Borough and FSHC on June 24, 2019; and

WHEREAS, according to the terms of the June 24, 2019 Settlement Agreement, the Borough planner prepared a HEFSP, which is attached hereto as Exhibit A; and

WHEREAS, the Municipal Land Use Board wishes to adopt an updated HEFSP to address the Borough of River Edgeøs affordable housing needs pursuant to its Mount Laurel obligations; and

WHEREAS, upon public notice duly provided pursuant to <u>N.J.S.A.</u> 40:55D-13, the Municipal Land Use Board held a public hearing on the updated HEFSP on February 19, 2020; and

WHEREAS, the Municipal Land Use Board has determined that the updated HEFSP entitled õHousing Element and Fair Share Plan, Borough of River Edge, Bergen County, New Jerseyö, dated February 6, 2020, prepared by Thomas Behrens, Jr. PP, AICP of Burgis Associates, Inc., meets the requirements of N.J.S.A. 40:55D-28(b)(3) and N.J.S.A. 52:27D-310 and is consistent with the goals and objectives of the Borough of River Edge Master Plan; and

WHEREAS, the Municipal Land Use Board has determined that adoption and implementation of the updated HEFSP is in the public interest and will protect public health and safety and promote the general welfare; and

NOW, THEREFORE, BE IT RESOLVED, by the Borough of River Edge Municipal Land Use Board that the Municipal Land Use Board does hereby adopt the HEFSP entitled õHousing Element and Fair Share Plan, Borough of River Edge, Bergen County, New Jerseyö, dated February 6, 2020, prepared by Thomas Behrens, Jr. PP, AICP of Burgis Associates, Inc.; and

BE IT FURTHER RESOLVED, that the Land Use Clerk shall forward a copy of this Resolution to the Borough Council for its consideration.
